Mississippi Hereford Feeder Calf Sale Requirements

***Enrollment: by September 15, 2026**

Type and Kind

- Must be sired by Reg. Hereford or Red Angus bulls (Natural service or A.I.) Registration paper or valid proof required
- Half Brahman steers will be allowed, but will be sorted and sold together.

Weaning & Nutrition

- Calves must be 45 days weaned, on feed, and drinking from water tank.
- Try to avoid overly fleshly cattle.

Health Records

- Complete, sign and submit the sale certification form regarding the name of vaccines, lot/serial number and dates of administration to Lande Johnson.

Processing

- All bulls must be castrated and healed. Calves appearing to be stags at grading will sell as singles.
- All calves must be dehorned and healed! NO EXCEPTIONS.
- All off or #2 cattle will be penned separately and will sell through the sale barns regular run sale.
- Please place all injections in the neck area!

Cattle Sorting

- Calves will be sorted according to color, sex, weight, and then sold in truck load lots.

Ear Tags

- MS Hereford/Red Angus Tags are required.
- They may be ordered from Lande Johnson at cost.

Commission and Fees

- All other fees will be deducted by Lincoln County Livestock Comm. from your check at their regular rates.

Verification

- Calves subject to be source verified by a MS Hereford sale representative!
- By signing this contract, you are guaranteeing these calves to be at least 50% Hereford or 50% Red Angus..

ALL SALES ARE FINAL!

- Heifers are guaranteed open at time of sale. It is recommended that a shot of Lutalyse be given to any suspected bred heifers! Bred heifers subject to a \$100 penalty!
